in accordance with Law. & the Clerk of this Court is hereby  
ordered to furnish the Commissioners Court, of Uvalde, & of  
Maverick Counties respectively with a certified Copy, or Notice  
of this order, as the Law requires. the said H. C. Petty, to  
begin running said Lines on the first day of September 1887.

Whereas, at a meeting of the Hon. Commissioners Court of Kinney Co. held on the 23<sup>d</sup> day of September 1887. The following order was entered on the minutes of said Court to-wit:

" County Lines

The matter of examining & approving the Field Notes of the Surveying the County lines between Kinney & Uvalde & Kinney & Maverick Counties. made by H. C. Petty a practical Surveyor. Appointed. Served & bonded, as required by Law, coming up before the Court. The said H. C. Petty Surveyor as aforesaid having made due return of the Field Notes & maps of the said Survey, to the Commissioners Court of Kinney County. And it appearing to the Court, that the Commissioners Court of Uvalde & Maverick Counties had received a copy of the order of Kinney County, authorizing & empowering said H. C. Petty to run said lines. Stating time to place for the commencement of the Survey, said notice having been given at least ten days before the meeting of said Courts, of both of said Counties. And it further appearing to the Court, that both of said boundary lines between Kinney & Uvalde, and Kinney & Maverick, was run, surveyed & marked out, in accordance with Law, & the Field Notes & maps of same, corresponding with said Survey. It is ordered that the same be approved, by the Court, & that it be recorded, by the County Clerk of Kinney County, & a certified copy of the same be returned to the Commissioners of the General Land Office."
