FIELD NOTES OF THE JACK AND CLAY COUNTY LINE

by R. W. Watkins, Surveyor of Clay County, and George Spiller, Surveyor of Jack County, begun Thursday, August 25, 1898.

Beginning on the West line of Montague County 4218 varas (two miles 418 varas) North of the S. W. corner of same, stone marked "J NE CO." "C SE C" two P. O.s marked H bear respectively N. 57 W. 1 vr. and S. 54½ W. 22 vrs. Thence with variation 9 deg. 8' East, West at 625 varas West line of E. T. R. R. Co. Survey 41, scrip 275, 693 varas N. of S. W. corner, at 1543 varas East line Freestone County School Land Survey, 1344 varas South of N. E. corner of subdivision of same and 295 varas North of S. E. corner of same.

1900 varas stone marked "1 C" North side "J" South side set for 1st mile.

3800 varas stone marked "2 C" North side "J" South side set for 2nd mile in garden in Newport, smoke stack Gin brs N. 87 W. large P. O. South side of road S. 59½ W., at 4813 varas stone on old line marked "11 V1", at 5544 varas fence between Sam Craig and D. S. Hodges.

At 5700 varas stone 3rd mile, marked "3 C" North side "J" South side, P. O. brs S. 85 W., at 5764 fence D. S. Hodges and Sam Craig, 375 varas South of line, at 6771 varas mile stone old line marked "111 V11" (variation 8 deg. 48' East), at 7276 varas in lane between Sam Craig and Wright.

7600 varas stone 4th mile marked "4 C" North side "J" South side same P. O. bearing from 3rd mile S. 79 E. corner in land N. 43½ E., 8120 varas West line Freestone County School Land Survey, 1314 vrs North of its S. W. corner East line Z. N. Morrell Survey, 1247 North of its S. E. corner, 8595 varas fence.

13300 varas 7th mile, stone "7 C" North side "J" South side, lone P. O. in prairie marked H East and West sides brs S. 87 W. 14433 creek, 14677 creek, 15140 varas small lone P. O. in prairie brs. S. 89½ E.

15200 varas 8th mile, large pile stone, 15500 varas West line Jesse B. Atkinson Survey, 2267 North of its S. W. corner, also East line of Wood County School Land, 15600 varas flat sand rock on top of bluff in skirt of timber marked for mile post "JV111 C" 16795 varas fence on Block line, 17100 varas in cotton patch P. O. brs. N. 35½ E. 54 vrs, 17230 vrs branch, 17556 varas center Post Oak and Henrietta road.

17556 varas stone for mile post, 9th mile, marked "J C" West side road, belfry church brs S. 58 W. 18238 varas, mile post old line "X111 - X1", 18368 varas road Block line 222 North of corner.

19000 varas 10th mile stone "JXC" belfry church S. 58½ E. school house S. 27 E. 20294 varas from Block line.

20900 varas 11th mile, pile stone on East slope brushy hill side, one stone marked "J 11 C", 21260 varas center of line. 22225 varas fence.

22800 varas 12th mile stone set in small timbered hill, P. O. part dead brs N. 2 E. 7 vrs, 23020 varas creek course, S. E. 23255 varas center Prospect road, 23625 varas fence.

24700 varas 13th mile, stone on rocky, timbered hill marked "J 13 C", 25260 varas foot timbered ridge, 25413 varas fence in timber West line Wood County School Land Survey, edge Turkey Creek Valley, 25880 varas slough or small lake, 25770 varas Turkey Creek, 26290 varas 13th mile old line, stone "X111-XV11".

26600 varas 14th mile stone "J 14 C" on timbered ridge, P. O. brs S. 22½ W. 11 vrs, 26894 varas in road East line James Wilson Survey, 480 varas South of its N. E. corner, ~~28215~~ varas 14th mile old line.

28500 varas 15th mile stone in prairie pasture, S. H. Melugin house brs N. 53½ E. P. O. in cluster of four brs N. 29½ W. 557, 28866 varas lane, 29633 varas P. O. line tree South of Melugin house, 30138 varas 15th mile old line, stone in cotton patch "XIV".

30400 varas 16th mile, pile stone top or rocky, timbered ridge, 30646 varas creek course N. E., 30760 varas East line T. F. Johnson in land, 490 varas South S. W. corner E. W. East, 200 vrs North M. Mitchel Putman, 32068 varas mile stone old line "XV1-XX", 32260 vrs

32300 varas 17th mile, 32320 vrs sand rock "J" 17 C" 32360 varas, 32380 same creek, 32620 varas east edge of valley, 32720 varas same creek, 32940 varas west edge of valley, 33170 varas top timbered hill, 33220 varas valley, 33855 varas Lodge Creek course S. W., 33916 varas fence West line W. F. White Survey, 206 varas North of its S. W. corner.
