Dear Mr. Giles:

The Director has asked me to reply to your letter of January 18, in which you request final 1950 population figures for the counties of Texas.

While final 1950 population figures for the United States, by States, are now available, we do not as yet have the figures for counties, cities and other areas within the States. The returns for persons enumerated away from their usual place of residence are first reallocated on a State basis only, in order to obtain final State totals as quickly as possible, and are not assigned to individual localities until later.

I regret that our schedule has been considerably delayed as a result of the National emergency, and we do not expect to have the final figures for Texas until next August. We have listed both you and Secretary Sheppard to receive press releases of these data when issued.

We are enclosing for your files the press release containing preliminary counts for the Texas counties and incorporated places of 1,000 or more inhabitants and the one which gives the final figures for the United States by regions, divisions and States. A copy of this letter, together with enclosures, is being sent to Secretary Shepperd.

POPULATION OF CONTINENTAL UNITED STATES BY REGIONS, DIVISIONS,
AND STATES: APRIL 1, 1950

(The figures for 1950 in this report are final and supersede figures for the same areas which appear in Series PC-2, Nos. 1 to 49 and Series PC-3, No. 1)

The total population of the United States on April 1, 1950, was 150,697,361, according to an announcement of final figures from the 1950 Census of Population made today by Roy V. Peel, Director, Bureau of the Census, Department of Commerce. During the last 10 years, the United States experienced an all-time record population growth between successive censuses of 19,028,086. The growth of population during this decade was nearly 2,000,000 greater than the former intercensal record growth of 17,064,426 for the period between 1920 and 1930. Between 1940 and 1950, the population of the United States increased at a rate of 14.5 percent, or twice as rapidly as during the thirties. As in the past, the West was the region with the greatest rate of growth, 40.9 percent. Each of the other three regions of the United States increased in population, but the rate of growth in these regions was far below that of the West.

For the first time, the West led the regions in the amount of increase in population, 5,678,260, as well as in the rate of increase. The major part of this gain was concentrated in the Pacific Division, that is, the States of California, Oregon, and Washington. In the Mountain Division, population increased at a rate appreciably higher than the national average, but because the division is relatively sparsely settled, the population gain amounted to only 924,995.

The most prominent population increase among the States was that of California, the population

of which in 1950 was 10,586,223, representing an increase of 3,678,836, or 53.3 percent, over the 6,907,387 inhabitants enumerated in the 1940 Census. Population growth in this one State exceeded that of the entire Northeast Region. As a result of the spectacular increase in population in California, the State now ranks second to New York in size whereas in 1940 it ranked fifth. Four other States, New York, Texas, Michigan, and Ohio, had gains of over 1,000,000.

The only State other than California to gain at a rate in excess of 50 percent was Arizona. The bordering States of Nevada, Utah, and New Mexico all had gains of more than 25 percent, and together with Arizona form a second center of rapid population growth. A third center of heavy population growth is found in and near the seat of the United States Government. The District of Columbia, Maryland, and Virginia each had increases of more than 20 percent.

Nineteen States and the District of Columbia gained at a more rapid rate than the Nation as a whole. Of the remaining States, all but four gained population. The four States with population losses were Arkansas, Mississippi, North Dakota, and Oklahoma. The losses and the rates of declines were relatively small. The numerical declines ranged from fewer than 5,000 in Mississippi to slightly more than 100,000 in Oklahoma. These States also had the lowest and highest rates of decline, 0.2 and 4.4 percent, respectively.

POPULATION OF TEXAS, BY COUNTIES
APRIL 1, 1950

(The figures in this report are preliminary counts of population as compiled in field offices and supersede those for the same areas which have been published in Series PC-1. Figures for some areas not published in Series PC-1 are also included in this report. Additional reports in Series PC-2 will be issued as preliminary counts for other States become available)

The population of Texas as of April 1, 1950, was 7,677,832 according to a preliminary count of the returns of the 1950 Decennial Census of Population, reported today by Roy V. Peel, Director, Bureau of the Census, Department of Commerce. This figure represents a gain of 1,263,008, or 19.7 percent, over the 6,414,824 inhabitants of the State enumerated in the 1940 Census.

The preliminary population counts shown below represent the number of

persons enumerated in the State, each county, and each incorporated place of 1,000 or more, but not the final verified population totals. The final population totals may differ from the preliminary counts because of the allocation to the place of usual residence of persons who were enumerated elsewhere, the inclusion of crews of vessels docked within an area but not included in the preliminary count, and because of other revisions.
