I, Nedra J. Foster, Licensed State Land Surveyor in the State of Texas, do hereby certify that this plat reflects an on the ground survey performed by me according to law. All points shown on the shoreline were on the line of mean high water at the time of my survey, February 10, 2005. Lines connecting these points are listed on the map and are meander lines.

All coordinates are referenced to the State Plane Coordinate System, NAD 83, Texas South Central Zone, U. S. survey feet. All bearings and distances are grid. Tidal determinations were made utilizing the gauge at Pleasure Pier. Mean high water was established at 1.23' NAVD 88. The theta at cotton gin spike shown on plat is 01°58'29" and the combined scale factor is 0.999866470.

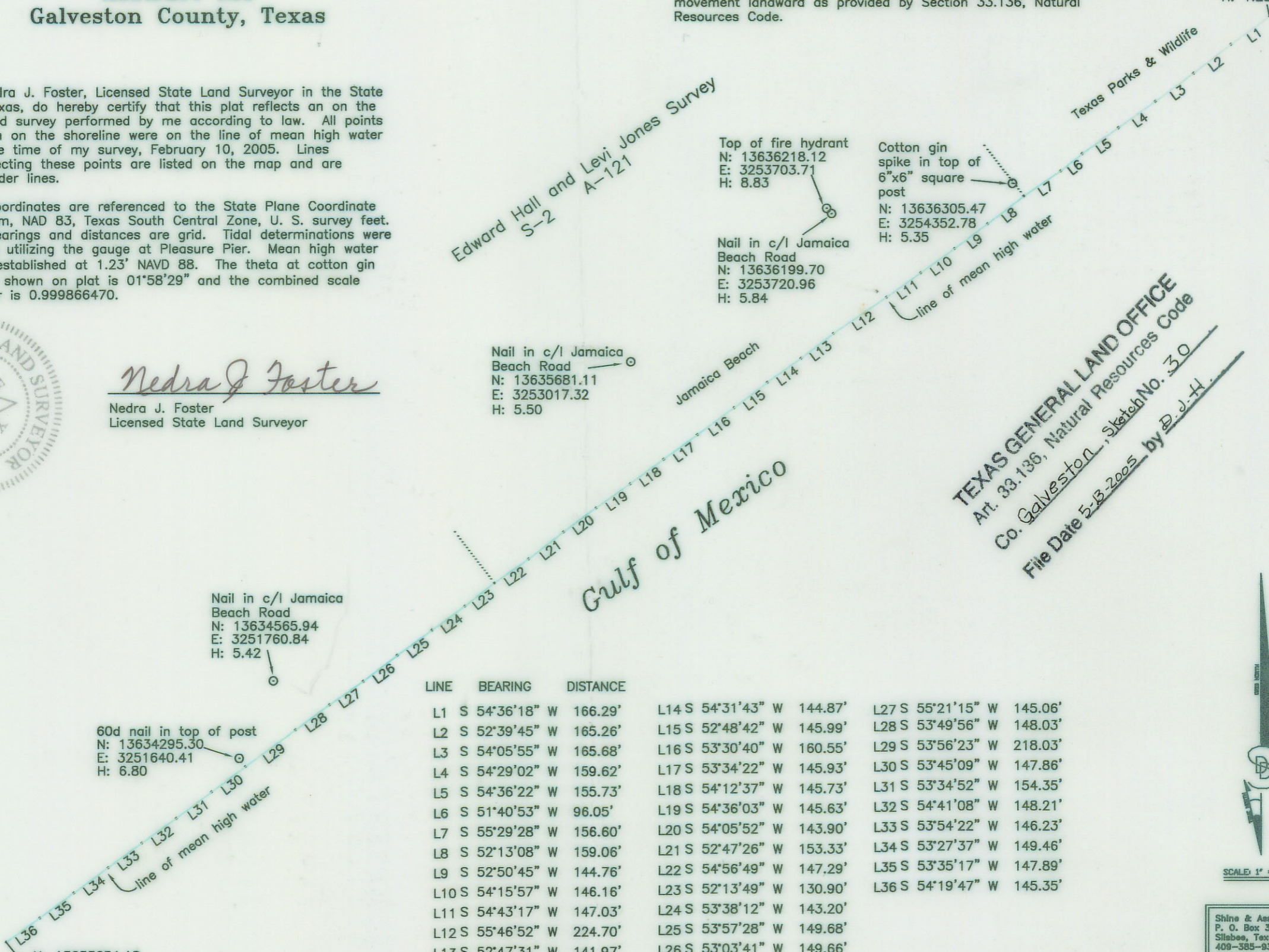
