The Commission interviewed Mr. Clyde E. Gray, prospective artist to render the mural for the State Archives and Library Building. Mr. Gray uses the medium of ceramic tile in his work. He estimated the cost of the mural in this medium would be between \$28.00 to \$35.00 per square foot and estimated there would be 533.4 square feet in the mural. The Council welcomed the Civics Class from WILLIAM B. TRAVIS HIGH SCHOOL.

The City Manager presented the progress report on the paving of Justin Iane, and submitted a proposal of A. B. BEDDOW to sell a 20' strip 900' long plus a building lot to the City for \$1250, and the City Manager stated if this were dedicated for street purposes, then the paving would be assessed against the property owners. Councilman Pearson suggested that the City Manager contact Mr. Beddow about giving the 20' strip and keeping the lot. MR. JIM BOX, 1200 Justin Lane, urged that the paving go through, and that the money not be refunded. The Mayor announced the progress that had been made and that ahlarger percentage had now signed up, and that the paving would go on with an assessment program. The Mayor asked that the press, radio and television give publicity that this paving program was going on now since the majority had signed up, and that the assessments would be made, and the matter started next week.

At 2:00 P.M. the Council met with MR. RALPH WOLE and MR. JIMMY JONES of the State Building Commission in connection with plans for the Courts and Office Buildings by the Capitol. Plans were displayed, showing the locations and parking spaces. Plans called for the vacating of the following streets:

> Colorado from 13th Street to 14th Street Brazos from 12th Street to 14th Street 13th St. from Brazos to San Jacinto Congress from 13¹/₂ Street to 14th Street 13¹/₂ St. from Colorado to Brazos

After a discussion was held, the Mayor canvassed the Council members, and each thought the plans were very nice, and each was agreeable to closing the streets when the property was acquired. Mayor Miller asked that Mr. Wolf and Mr. Jones come back before the Council when the property had been acquired. The Mayor stated he would like to get information on what the State had done in the las t several years in Austin, including the School for the Deaf, Highway Department, improvements to the State Capitol, and how much was contemplated being spent in the next five years. In general discussion of the plans of the Capitol grounds, the Council members expressed a hope that drives through the ground would be retained.

The Council went over the figures submitted for the proposed bond issues. The Director of Electric Utilities pointed out the needs for \$17,167,000 during the next five years, to cover underground networks, substations, street lighting, traffic signals, lines, construction, and buildings, etc. The City Manager stated that out of the \$17,167,000 only \$62 million would be from bonds. The rest would come from the revenue after maintenance, operation, transfer of \$2,750,000 to the General Fund, and refund contract payments, were taken care of.

Being all of that certain portion of East 13th Street as presently in use in the City of Austin, Travis County, Texas, which lies east of the southerly prolongation of the west line of Lot 4, Block 160 of the Original City of Austin, Travis County, Texas, and west of the southerly prolongation of the east line of Lot 4 of the said Block 160 of the Original City of Austin according to a map or plat of the said Original City of Austin, Travis County, Texas, on file in the General Land Office of the State of Texas.

NO. 5

Being a portion of a certain street, now known as W. 13th Street, in the Original City of Austin, Travis County, Texas, according to a plat of said Original City on file in the General Land Office of the State of Texas, which

AN ORDINANCE PERPETUALLY VACATING AND CLOSING A PORTION OF BRAZOS STREET; A PORTION OF EAST 13TH STREET AND THE EAST-WEST ALLEY TRAVERSING BLOCK 147, FROM SAN JACINTO TO BRAZOS STREET, ORIGINAL CITY OF AUSTIN, IN THE CITY OF AUSTIN, TRAVIS COUNTY, TEXAS, TO PUBLIC TRAVEL; RETAINING UTILITY EASEMENTS IN THE AREAS SO VACATED; AND SUSPENDING THE RULE REQUIRING THE READING OF AN ORDINANCE ON THREE SEPARATE DAYS.

WHEREAS, a street designated as East 13th Street and formerly known as Peach Street, an alley traversing Block 147 and a street designated as Brazos Street were dedicated to the public on the map or plat of the Original City of Austin, Travis County, Texas, on file in the General Land Office of the State of Texas; and,

WHEREAS, the State of Texas has acquired all lands abutting the hereinafter described portions of said streets and said alley and has requested said vacations with the retention of public utility easements in order to permit the optimum use of said abutting lands for the Capitol Area Expansion Program; and,

WHEREAS, said Program is consistent with the traditional good planning which has produced the orderly development of the Capitol area of the City of Austin and it is deemed advisable by the City Council, in the best interests of the public, to vacate and close the hereinafter described portions of said streets and alley to public travel; Now, Therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

SECTION 1. That the hereinafter described portion of East 13th Street formerly known as Peach Street; the hereinafter described portion of the east-west alley traversing Block 147, known as East 12th Street Alley, and the hereinafter described portion of Brazos Street, of the Original City of Austin, Travis County, Texas, according to a map or plat of the said Original City of Austin on file in the General Land Office of the State of Texas, be and the same are hereby perpetually closed and vacated for purposes of public travel; the public utilities easements rights in said streets and alley being specifically excluded from the above vacation; such portions of said streets and alley so vacated being more particularly described as follows:

> Three (3) tracts of land; the tract of land hereinafter described as No. 1 being a portion of a street known as East 13th Street formerly known as Peach Street in the City of Austin, Travis County, Texas, as shown on a map or plat of the Original City of Austin, Travis County, Texas, on file inthe General Land Office of the State of Texas; the tract of land hereinafter described as No. 2 being a portion of that certain alley traversing Block 147 of the said Original City of Austin; the tract of land hereinafter described as No. 3 being a portion of Brazos Street; each of the said three (3) tracts of land being more particularly described as follows:

NO. 3 BEING all of that certain portion of Brazos Street as presently in use, which lies north of the north line of East 12th Street, same being the westerly prolongation of the south line of the aforesaid Block 147 of the Original City of Austin and south of the westerly prolongation of the north line of the said Block 147 same being the south line of East 13th Street;

There is to be retained however, an easement for public utilities over the entire area of the three (3) tracts of land described above;

SECTION 2. The Ordinance rule requiring the reading of an ordinance on three separate days be and the same is hereby suspended and this Ordinance shall become effective as provided by the Charter of the City of Austin.
