Denton County; 43<sup>rd</sup> District Court of Parker County, Texas, I set a 30 inch aluminum monument in concrete with a Brass Disc marked with respective counties on March 30, 2005 to mark the common corner of counties referenced above.

After contacting me in late 2007-early 2008 the monument was removed by Hillwood Construction to allow for the development of an industrial park at the site of the monument. The original monument was secured and maintained by Hillwood.

On March 14, 2008, I reset the monument in a concrete drive within the industrial park. The location of the monument was determined by using the offset monuments, mark "Y" on concrete bases of an electric transmission line, as shown on page 10 of 64 of my field notes of the Tarrant/Denton County Line on file with your office.
