NAVD 88 orthometric heights derived from the GEOID12A (CONUS) gravity model. Mean convergence angle is (+) 00°15'16". Subject: Survey report of 4,100.3 acres of land aggregated out the parent tracts of Wolters Air Force Base, now vested in the Department of the Army and named Fort Wolters Training Center, situated in Parker and Palo Pinto County, Texas, on the waters of Rock Creek, a tributary of the Brazos River, about 16 miles North 60-1/4 deg. West from the courthouse in Weatherford, Texas, the county seat of Parker County.

I performed a retracement survey on the ground of the captioned lands in Parker and Palo Pinto County, Texas, and furnish this report, plat, and field notes herewith. The purpose of this survey was to locate the perimeter boundary of the aforementioned 4,100.3-acre tract presently known as the Fort Wolters Training Center (hereinafter called FWTC), making up the residual of several Declarations of Taking in the United States District Court for The Northern District of Texas Fort Worth Division, styled, "United States of America vs. 3481.29 Acres of Land in Palo Pinto and Parker Counties, Texas, and Camp Wolters Enterprises, Inc. et al.", No. 2142 Civil. At the Deed Records of Parker County, I searched in the Direct and Reverse indices and on computer with the aid of a county employee and retrieved only two adjudicated Declarations of Taking, to-wit:

- Judgement on Declaration of Taking No. 1, Tract No. A-3, A-4, A-5, A-7, A-8, & A-9 for an aggregate of 205.27 acres on 2 May 1951 and recorded in Volume 249, Page 201, Deed Records, Parker County, Texas
- Judgement on Declaration of Taking No. 3, Tract No. A-2 for 3216.4 Acres (net) on 2 May 1951 and recorded in Volume 252, Page 58, Deed Records, Parker County, Texas

I found no record of a Declaration of Taking No. 2 with the County Clerk. The 3,481.29 acres in the No. 2142 civil action made up a large portion of surplus land that went to the Mineral Wells Industrial Park after World War-II. Only 924.5 acres of the

Declaration of Taking No. 2 remains in FWTC. The 924.5 acres comes out of the 4,100.3 acres now vested in the Department of the Army.

#### LAND HISTORY

Rock Creek, a tributary of the Brazos River, courses from north to south through the eastern half of FWTC into Lake Mineral Wells. Two perennial branches, Teter's Branch and Rippy Branch drain into Rock Creek.

During World War-II, FWTC was "Camp Wolters" and made up about 23,747 acres. After the war, all but 7,976.19 acres was disposed of; some returned to former landowners and the rest sold to Camp Wolters Enterprises, Inc.

Reactivated In 1951, Camp Wolters was transferred to the Department of the Air Force and named "Wolters Air Force Base", and according to the official Real Estate Map of Fort Wolters dated 6 March 1987, Installation No. 2852, made up "Tract A" of 7,743.35 acres for a purchase price of \$1,167,430.85. Wolters Air Force Base served as a base to train the Aviation Engineer Force and a location for a Nike/Hercules Missile

complex. It remained active until 15 December 1956, when it was transferred to the Department of the Army and renamed "Fort Wolters", according to the official Real Estate map of Fort Wolters dated 6 March 1987, Installation No. 2852.




Figure 1. Present boundary of Fort Wolters Training Center overlaid onto Parker County Sketch File 10-Map of Surveys within the MEP&R. Ry. Reserve.

On 31 December 1956, the Department of the Army conveyed Tract A-101 for 66.80 acres to the Mineral Wells Chamber of Commerce by deed. According to said official Real Estate map of Fort Wolters, Tract A-101 was reacquired by the Department of the Army on 5 February 1958.

FWTC is now maintained and operated by the Texas National Guard, described in License No. DACA63-3-10-0527 from the Department of the Army for 3984.99 acres.

#### Chronology of FWTC follows:1

- 1921: Camp Wolters formed out of approximately 50 acres, 56th Cavalry Brigade of the Texas National Guard organized
- 1925: Grant for construction of Texas National Guard training camp given to Brigadier General Jacob F. Wolters
- 1940: October 13 Announcement made that Mineral Wells selected for location of Infantry Replacement Training Center
- 1940: November 12 Construction of training center begun
- 1941: March 22 Camp Wolters officially turned over to the U.S. Army
- 1941: April 5 Brigadier General William H. Simpson assumed command
- 1946: January 19 Infantry Replacement Center inactivated
- 1951: February Camp Wolters reactivated and re-designated Wolters Air Force Base
- 1956: July 1 Camp Wolters reverted to Army control with mission to train helicopter pilots
- 1956: September 26 U.S. Army Primary Helicopter School activated
- 1957: April 27 First class graduated from U.S. Army Primary Helicopter School
- 1963: June 1 Camp Wolters re-designated Fort Wolters, a permanent military installation
- 1966: March Post was designated U.S. Army Primary Helicopter Center for training Army aviators for combat duty in Viet Nam
- 1973: The helicopter school transferred to U.S. Army Aviation School at Fort Rucker, Alabama

#### SURVEYING ON THE GROUND

In November 2020, I received a request from the Texas Military Department Real Property Manager to survey the perimeter boundary of FWTC in response to a directive from the National Guard Bureau, Washington, D.C. to report on actual acreage of FWTC, which was never accurately known before my survey.

Eight years before the retracement survey, I established a permanent geodetic control network on FWTC during the week of 7 November 2013. This was set up for the eventual retracement survey. From 2013 to 2021, I researched and prepared a working sketch when I could fit it in to my schedule. I commenced fieldwork on 7 November 2013 assisted by Mark Hinojosa, Certified Survey Technician, and completed the survey on 29 July 2021. Our last field trip to FWTC was to tie in the perimeter fence the week of 26-29 July 2021, by teaming up with the 176th Engineer Brigade Survey Section, Texas Army National Guard. Completing this task in record-breaking heat and humidity would not have been possible without the efforts of the 176th Engineer Brigade surveyors.

Bearings, distances and coordinates are referenced to the Texas Coordinate System, Lambert conic grid projection, NAD 83(CONUS) Texas North Central Zone 4202. Five primary control stations on the project site were positioned by static satellite observations and post-processed in a least squares network adjustment horizontally

constrained to the WGS-84 ellipsoid latitude & longitude position, and ellipsoid height of Mineral Wells CORS Station TXMW (NAD 83, (2011) epoch 2010.00), and CT1192, a National Geodetic Survey Secondary Airport Control station for the Mineral Wells Municipal Airport. In the same network adjustment, NAVD 88 orthometric elevations were derived from the GEOID12A(CONUS) gravity model and vertically constrained to CORS TXMW, and the network elevations agreed with CT1192 by -0.075 feet. A-priori scalar weighting was set to 1 and the adjustment passed the chi-square and tau tests at the 95 percent confidence level in the second iteration. Mean meridian convergence angle of the project site is (+)00°15'16". Distances shown are surface with a ground scale factor of 1.000167 computed from Station 500 (32°52'00.04318"N // 098°02'28.29419"W // ellipsoid height 937.328'), which transformed the project control into a local coordinate system.

The delineation of the FWTC boundary and corner monuments found or set are easily seen and understood on my survey plat and field notes accompanying this report. All perimeter corners of FWTC found and set were marked with orange Carsonite survey witness posts. It was necessary to locate the joinder tract corners around FWTC. An abundance of these joinder corner monuments was found to provide evidential proof of their locations relevant to the FWTC boundary.

#### **BOUNDARY CONSTRUCTION**

The extant FWTC land was surveyed when the Air Force acquired it in 1956, found monuments attest to that; however, many of the calls in the written description described in License No. DACA63-3-10-0527 for 3,984.99 acres were substantially off the found courses and distances, which did not reference to the Air Force survey. Said license admits in Paragraph 18.b. that the written description is not representative the perimeter of FWTC and discrepancies in area were found. Construction of lost or obliterated corner monuments was by translation and rotation of record lines to found lines, looking for a fit. Some construction was by deed bearing-bearing intersection, and some by distance-distance intersection to see what fit best and made sense.

#### WBL from Corner Points 1-8

We found corner Point 1 intact, a concrete monument with bronze disk stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK about half a foot west of a barbwire fence. The record call for this corner was to be in the common line of T.&P. RR. CO. Surveys 2 & 11. We ran southerly 1420.73 feet along said fence and found a 2-inch iron pipe standing about a foot above ground (Point A), which I accepted as the perpetuated common corner of T.&P. RR. CO. surveys 2, 3, 11 & 12. It was marked up

with survey flagging and wooden laths, and in the right location. Point A is referenced in many surveys of the Wolters industrial complex as a tie to a survey corner.

We found Point 2, a 2-5/8-inch iron pipe originally called for in the record description. Found distance between Point 1 & 2 was 3868.06 feet, which was short by 2.82 feet of record call. We located corners along the SBL of the John T. Baker tract making up the 320-acre W/2 of the T.&P. RR. CO. Survey 1. The SWC of said Baker tract was called to be a spike set in the center of Marsden Road (gravel surface). By common reputation, this was accepted as the perpetuated common corner of T.&P. RR. CO. surveys 1, 2, 10 & 11. Using a magnetometer, we did not find the spike due to county road maintenance, so I reset this corner with a railroad spike and named it Point B.

The WBL of FWTC from Point 1 to Point 2 is 7.9 feet west of the survey line connecting Points A & B whose course and distance is N 00°17'32" W 5309.64 feet. Point B bears N 20°25'08" E 22.31 feet from Point 2.

We searched unsuccessfully for Point 3, purportedly next to an ancient wood fence corner post. The corner monument had been removed by FWTC personnel and thrown in a ditch 40 feet to the west of its original location. It was a bronze disk marked WOLTERS AIR FORCE BASE still encased in concrete. No one from FWTC reported the removal or claimed responsibility. It is a federal offense to willingly and intentionally remove a U.S. government survey mark, amounting to imprisonment and fines.

From the approximate Point 3 location, we ran north and found Point 4 to be a concrete monument with bronze disk marked WOLTERS AIR FORCE BASE solidly intact. I constructed Point 3 by giving the called distances of 5326.00 feet from Point 2 and 5329.00 feet from Point 4, a found concrete monument with bronze disk marked WOLTERS AIR FORCE BASE near a steel fence corner post. I accepted Point 4 to be the called for NEC of the T.&P. RR. CO. Survey 1, common with the NWC of the M.E.&P. RR. CO. Survey 379, and in the SBL of the T.E.& L. CO. Survey 2661 as called out in the written description.

We easily found Point 5, a concrete monument with bronze disk marked WOLTERS AIR FORCE BASE near a steel fence corner post. The found distance was 845.07 feet, 24.93 feet short of called distance 870 feet. Furthermore, the call for this line was 'westerly', and at this point I did not trust many of the called courses. I accepted Point 5 to be the SWC of the T.E.& L. CO. Survey 2661 as called out in the written description.

Points 6, 7 & 8 were found iron rods with brass caps stamped U.S. GOVT. PROPERTY CORNER. The line connecting Points 6 & 7 was 1455.05 feet, very close

to the called distance 1455.00 feet. The line connecting Point 7 & 8 was 1591.68 feet, which was also close to the called distance of 1591.50 feet. Point 8 was found in the south line of Lamkin Road.

#### NBL from Corner Points 8-27

We were unsuccessful in finding Points 9, 10 & 11. They were called to be iron pipes. I attempted to reconstruct these corners by holding deed angle from Point 7 to 8, but this threw Points 9-11 into Lamkin Road. To make matters worse, the called for iron pipes marking points 10, 11, 12, 13, 14 & 15 were not found. I had to reconstruct this line by going all the way to Point 15, a found 4-inch steel fence corner post as called in said John L. Graham's 17-acre tract. I found Graham's SWC, a capped iron rod marked PRICE SURVEYING. In order to construct the line from Point 15 all the way back to Point 11, I used the line connecting Point 15 to the capped iron rod as a controlling line, as it was the only evidence of a boundary line I could find. I also reversed the called bearing from Point 13 to 14 from S 88°05' E to N 88°05' E. This way the constructed NBL would fit the joinders SBL and put Point 11 at a found 4-inch steel fence corner post marking the SWC of said William C. Council's 10.578 acres. This seemed sensible to be a common corner with FWTC, in the SE line of Lamkin Road. The distance between Point 11 & 15 is 2291.85 feet, excessive by 79.85 feet of call. Point 10 was set per called deed angle and distance. Point 9 was set near an ancient fence corner post. the called distance of 222.90 feet from Point 8. They were both set 1/2-inch iron rods with 3-1/2-inch aluminum caps stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK.

Following the constructed NBL from Point 11, I set 1/2-inch iron rods with 3-1/2-inch aluminum caps stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK for Point 12 & 13, giving their called distances of 833.00 feet and 3.00 feet, respectively. From Point 15, I gave the called distance of 567.00 feet extending a line from Point 15 through the PRICE SURVEYING capped iron rod and set a 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK. This made the distance between Points 13 & 14 to be 891.95 feet, 79.75 feet in excess of the called distance of 812.20 feet.

I accepted the line connecting Points 15 & 16 to be on the EBL of said John L. Graham's 17-acre tract whose NEC was a 4-inch steel fence corner post in the south line of Lamkin Road. I gave the called distance of 1803.40 feet from Point 15 and set a 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK. Graham's NEC bears North 00°36'47" West 14.08 feet.

We searched for Points 17 & 18 and only found a removed iron rod with brass cap stamped U.S. GOVT. PROPERTY CORNER lying on its side in the vicinity of Point 18.

We found Point 19 to be an iron rod with brass cap stamped U.S. GOVT. PROPERTY CORNER, bearing North 04°28' West 20.4 feet from a 4-inch steel fence corner post. I constructed the NBL from Point 19 through a found 1/2-iron rod next to a railroad tie marking the SWC of the David Leon Buschow, Jr. 5.00-acre tract, setting a 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK for Point 18, giving the called distance of 2491.00 feet. I constructed Point 17 by deed angle and distance of 101.20 feet and set a 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK. I accepted Points 17 & 18 to be in the called for common line of the T.E.& L. Co Survey 2662, A-1323 and the E.A. Calvert Survey, A-2103, and Point 18 to be the SWC of the W.W. Churchill Survey, A-2195, as perpetuated by me.

From Point 19, we found Point 20 to be a concrete monument with bronze disk stamped WOLTERS AIR FORCE BASE at 1379.67 feet, just short of the called distance of 1380.00 feet. I took this to be the SWC of the 80-acre Elva Lyn Fishman tract. I accepted Points 19 & 20 to be in the called for common line of the W.W. Churchill Survey and the J.A. Stinson Survey, A-2174.

The NBL from Points 20, 21, 22, 23 & 24 was constructed from the nearest found monument, Point 24, a concrete monument with bronze disk stamped WOLTERS AIR FORCE BASE in a barb wire fence, by deed angles and partly by called distances. I gave the called distance of 2070.80 feet to Point 21, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK, at the apparent SEC of said Elva Lyn Fishman 80-acre tract. I accepted Point 21 to be in the called for common line of said J.A. Stinson Survey and the D.W. Lamkin Survey, A-2565, as perpetuated by me.

From Point 21, I ran northerly along a barb wire fence the called distance on 551.50 feet to Point 22, a found, recessed circular mound of rocks in an ancient barb wire fence I accepted to be NEC of said D.W. Lamkin Survey and the most southerly SWC of the J.A. McClung Survey, A-2334, as perpetuated by me. I drilled a punch hole in center of this rock mound.

Point 23, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK in a rock mound, was constructed by deed bearings from Points 22 & 24. The distance between Points 22 & 23 is 1111.62 feet,

short of the called distance of 1125.00 feet. The distance between Points 23 & 24 is 121.74 feet, very close to the called distance of 121.70 feet.

I constructed Point 25, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK by deed angle and called distance of 537.30 feet from a line connecting Points 26 & 27, both being found concrete monuments with bronze disks stamped WOLTERS AIR FORCE BASE. From Point 25, a 4-inch steel fence corner post bears North 12°20'28" East 29.9 feet. The distance from Point 26 to 27 is 2093.50 feet, 16.50 feet longer than the called distance of 2077.00 feet.

### **EBL from Corner Points 27-36**

Point 28, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK, was constructed by intersecting the called distance of 5307.50 feet from Point 27, and 686.60 feet from Point 29, a found concrete monument with bronze disk stamped WOLTERS AIR FORCE BASE near a 4-inch steel fence corner post. A wood fence corner post at the SWC of a fence of occupation bears North 87°37' West 68.7 feet. It is unknown whether FWTC built this fence or if the owners of the William C. Martin and Mary Dell Living Trust Tracts One & Two did. I found a 3/8-inch spike nail as called for the SEC of the Karen L. Hurst et. al. 61.725 acre tract, sharing the NWC of said Martin and Mary Dell Tracts One & Two. This corner is 9.71 feet outside FWTC and intersects the center of Stafford Road and Smith Trail. I fit said Karen L. Hurst et. al. 61,725 acre tract and Martin and Dell Tracts One & Two by rotating the tracts from said 3/8-inch spike nail to a found 3/8-inch iron rod on the north line of Smith Trail, sharing the SEC of said Karen L. Hurst et. al. 61,725 acre tract and the SWC of the Ann S. Morris et al. 38.848 acre tract. The SBL of said Karen L. Hurst et. al. 61.725 acre tract is common with the NBL of Martin and Dell Tracts One & Two and crosses the center of Smith Trail to a point in the north line of Smith Trail. The WBL of said Martin and Dell Tracts One & Two fits the fence line running northerly from the steel fence corner post near Point 28. There is a 20-foot private locked gate for a road thar runs southerly crossing the EBL of FWTC, staying inside said fence of occupation, and makes a left turn crossing the WBL of said Martin and Dell Tracts One & Two, about 50 feet north of Point 28.

The EBL continued southerly, finding points 30 & 31, both found concrete monuments with bronze disks stamped WOLTERS AIR FORCE BASE near steel fence corner posts. I accepted Points 30 & 31 to be in the called for common line of the T.&P. RR. CO. Survey 345, A-1539 and the R.I. Carr, J.T. Carr & E. Van B. Sweatt Survey, A-2525, and Point 31 to be the called most northerly NEC of said R.I. Carr, J.T. Carr & E.

Van B. Sweatt Survey. The distance between Point 29 to 30 was found to be 2641.87 feet, 0.67 feet longer than the called distance of 2641.20 feet. Found distance from Point 30 to Point 31 is 834.38 feet, 1.28 feet longer than the called distance of 833.10 feet.

Point 32, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK, was constructed by intersecting the called distances of 338.20 feet from Point 31 and 1123.00 feet from Point 33, a found concrete monument with bronze disk stamped WOLTERS AIR FORCE BASE near steel fence corner post. I accepted Point 32 to be the called for SWC of the Richard Colter Survey, A-1936, as perpetuated by me, and the apparent SWC of the called 80-acre to Maddux Farms, Ltd. tract.

Continuing southerly, near a barb wire fence, Point 34 is a found concrete monument with bronze disk stamped WOLTERS AIR FORCE BASE near steel fence corner post, in or near the common line of the T.&P. RR. CO. Survey 343, A-1496 and the A.C. Stanley Survey, A-1266, 6106.77 feet from Point 33, 0.97 feet longer than the called distance of 6105.80 feet.

We found Points 35 & 36, found concrete monuments with bronze disks stamped WOLTERS AIR FORCE BASE near steel fence corner posts. Found distance between Point 34 to 35 is 1133.92 feet, very close to the called distance of 1133.80 feet. From Point 35 to 36, the found distance of 669.36 feet, 0.56 feet longer than the called distance of 668.80 feet.

#### SBL from Corner Points 36-58-1

The SBL from Point 36 to 37 is called to run with the common line of the T.&P. RR. CO. Survey 343, A-1496 and the Jacob A. Whitten Survey, A-1622 when the SBL crosses Howard Road. Point 37 was called to be an iron pipe. We made searches for this corner on several trips to FWTC but did not find it, probably because the point fell next to a bar ditch and may have been removed. We could not establish the location of Point 37 without first finding a called for iron pipe at Point 38, which was gone. Then we found two 2-inch iron pipes on the NBL of the 1748.84-acre Texas Parks and Wildlife Department tract for and inner corner near the end of Little Reba Ranch Road, said line being the accepted SBL of the J.C. Maddux Survey, A-996 and the E. Van B. Sweatt Survey, A-1273. I constructed a line between the two found iron pipes and extended it giving the called distance of 1318.70 feet for that line of said Texas Parks and Wildlife Department 1748.84-acre tract. This established the location of Point 38, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY

SURVEY MARK. Point 37, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK, was constructed by deed angle through Points 39-38-37 and giving the called distance of 4496.00 feet from Point 38 to 37, which placed the corner in an old barb wire fence on the south line of Ballew Springs Road. The constructed line from Point 36 to point 37 is 4115.80 feet, considerably shorter than the called distance of 4153.10 feet; however, if I gave the called distance, Point 37 would be on the west line of Little Reba Ranch Road. The called location of Point 37 is said to share the common corner of the T.&P. RR. CO. Survey 343, A-1496 and the T.&P. RR. CO. Survey 355, A-1354. This made sense when I lined up Point 37 and connected it to a found 60D spike in the center of Little Reba Ranch Road bearing South 88°10'16" West 26.57 feet from Point 38, said spike was called to be the NEC of said William Lloyd Collins & Esta Leos 41.721-acre tract. I believe the survey line ran up the centerline of Little Reba Ranch Road, but the FWTC line at Point 38 bowed to the east by 26.57 feet. The line connecting Points 38 & 39 bowed back to the west with a deflection angle of 00°21'39" to the left. Point 39 is a found concrete monument with brass disk stamped "TEXAS PARKS AND WILDLIFE" around a five-point star. I believe Point 39 is located in the in the common line of the T.&P. RR. CO. Survey 345, A-1539 and the T.&P. RR. CO. Survey 353, A-1542, as called for in the written description.

The found line connecting Points 39 & 40 ran along the general course of a barb wire fence a distance of 5339.96 feet, 2.21 feet short of the called distance of 5342.17 feet. Point 40 is a found concrete monument with brass disk stamped "TEXAS PARKS AND WILDLIFE" around a five-point star.

Point 41, a found 2-inch iron pipe as originally called for is in a ravine, more particularly the Teter's Branch of Rock Creek, and 11.6 feet west of an old barb wire fence. This corner was very difficult to get to due to the steep terrain. The found distance between Points 40 & 41 is 2994.65 feet, 1.93 feet short of the called distance of 2996.58 feet.

Continuing along the general course of a barb wire fence, we found Point 42, a concrete monument with brass disk stamped "TEXAS PARKS AND WILDLIFE" around a five-point star. The found distance between Points 41 & 42 is 7911.41 feet, very closely matching the called distance of 7911.54 feet.

Point 43 is a found concrete monument with brass disk stamped "TEXAS PARKS AND WILDLIFE" around a five-point star, and 243 feet west of the barb wire fence, where the FWTC staff believes the boundary line is. The found distance between Points 42 & 43 is 2983.99 feet, 16.01 feet short of the called distance of 3000 feet.

Point 43 was the last of the Texas Parks & Wildlife concrete monuments with brass disks to be found. They were all called to be iron pipes, but we can assume Texas Parks & Wildlife Department re-monumented their corners.

Point 44 is a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK at the north base of a steel fence corner post. I believe the original monument was removed when the steel fence gate was built. I constructed Point 44 by deed angle and called distances from Points 46-45-44. I connected a line from Point 43 to Point 44 and set it to within one foot of said post, a distance of 877.60 feet, 13.2 feet excess of the called distance of 864.40 feet.

To support my construction of Point 44, we found Point 46, a 2-inch iron pipe that sticks out of the ground by 1.2 feet. I accepted this to be the original corner common with FWTC and said Texas Parks and Wildlife Department 1748.84-acre tract. Point 46 is in a chain link fence that runs around the FWTC ammunition storage facility. From there, I constructed Point 45, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK in a bar ditch by giving the called distances of 876.06 feet from Point 44 and 1323.00 feet from Point 46.

Running the chain link fence around the FWTC ammunition storage facility from Point 46, the Texas Parks & Wildlife Department boundary is called to run with a fence. Points 47-51 are chain link fence corner posts. The found distances between Points 46-47-48-49 & 50 agreed to within a couple tenths of a foot. Found distance between Points 50 & 51 is 1305.88 feet, 1.49 feet short of called distance 1307.37 feet. It is likely this chain link fence was repaired in the past and new fence posts were put in.

Point 52 is a found 5/8-inch iron rod in the east line of Heintzelman Road along the projected line of an old barb wire fence. The found distance between Points 51 & 52 is 467.65 feet. The call for this line in the Texas Parks and Wildlife Department 1748.84-acre tract is a "calculated bearing and distance of S 66°39'19" E 462.91 feet to a corner fence post".

The line between Points 53 & 54 was constructed by 80-foot-right offset of a line connecting a found City of Mineral Wells brass monument marking the intersection of the west line of Heintzelman Road and the south line of Wagner Road and a found 5/8-inch iron rod marking intersection of the south line of Wagner Road and the east line of Hood Road. Point 53, a set 1/2-inch iron rod with 3-1/2-inch aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK in a bar ditch was constructed by intersection of said 80-foot line offset and the projected line of the east line of Heintzelman Road through Point 52. Point 54, a set 1/2-inch iron rod with 3-1/2-inch

aluminum cap stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK, was constructed by intersection of said 80-foot line offset and the projected 513.45-foot-radius curve in the south line of the United States of America 155.11-acre Tract I. The distance between Points 53 & 54 is 1291.90 feet, 5.71 feet longer than the called distance of 1286.19 feet. This difference is due in large part from the erroneous curve data called in the original description. The curve along the north line of Hood Road is called to have a 433.45-foot radius (which is supposed to be the radius for its south line), the chord distance is called to be 744.51 feet and an unrealistic 118°21'56" central angle. The correct curve on my survey gives a 513.45-foot radius, a 78°12'02" central angle, a chord distance of 647.64 feet, and an arc distance of 700.79 feet.

Point 56, a set railroad spike in the center of a gravel range road marking the NEC of said United States of America Tract I, was constructed by deed angle and distance from Points 1-57-56. Point 55, a set railroad spike in asphalt pavement marking the SEC of said United States of America Tract I, in the north line of Hood Road, was constructed by deed angle and distance from Points 57-56-55.

Points 57 & 58 mark a straight line all the way through Point 1. Point 57 is a found concrete monument with bronze disk stamped CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK standing upright, about six feet south of a barb wire fence. Point 58 is a found broken concrete monument missing its CORPS OF ENGINEERS-U.S. ARMY SURVEY MARK disk 1744.19 feet WSW from Point 57. A survey of 2,349.894 acres made in 1973 by T.D. Disheroon for the U.S. Army Corps of Engineers does not show Point 58 on Line 57-1 as being a point of tangency (P.O.T.).

The final call from Point 57 to Point 1 is a found distance of 3076.29 feet, 1.10 feet longer than the called distance of 3075.19 feet.

#### **BOUNDARY CONFLICTS**

The SBL of FWTC from Points 1-57-56 has multiple corner overlaps by private property amounting to 0.585 acre. Compared to 4,100.3 gross acres, this is a small quantity of land encroaching into FWTC. However, the overlapping corner monument distances of the RB Land & Cattle Company tracts in Vol. 2464 Pg. 1299 & Vol. 2889 Pg. 719, Parker County Deed Records, are large. These tracts appear to have been surveyed by a local company named Price Surveying and the RB Land & Cattle Company corner monuments fall 6.6 feet into FWTC from Point 57, and 6.48 & 8.02 feet as shown on my survey. I cannot explain the thought process of Price Surveying ignoring Points 1, 57 & 58, which are U.S. government boundary monuments. A 1.28-

foot corner monument overlap occurs at the NWC of Odis N. Dow, Vol. 1377 Pg. 677, Palo Pinto County Deed Records.

Another corner overlap occurs in the NBL of FWTC, 806.4 feet east of Point 18 and 11.21 feet into FWTC. This corner appears to be the SEC of David Leon Buschow, Jr. 5-acre tract in Vol. 2344 Pg. 1196, Parker County Deed Records and amounts to 0.0987 acre.

The EBL of FWTC has no found conflicts into FWTC, but the joinder tracts to the east of the line connecting Points 33 & 34 do not touch our EBL, bringing to issue of the Strip-and-Gore Doctrine. The NWC and SWC of the Coalson 2009 Dynasty Trust 72.809-acre tract, Instr. 201808917, Parker County Deed Records are out by 15.35 feet and 27.63 feet, respectively, the latter sharing the NWC of Sue Ann's Flying Star Ranch LLC 81.523-acre tract in Vol. 2885 Pg. 1122, Parker County Deed Records. The SWC of Sue Ann's Flying Star Ranch LLC tract is 7.13 feet out and shares the NWC of Ashley Olles' 27.321-acre tract, Instr. 201516478, Parker County Deed Records. Olles' SWC is only 1.19 feet out, sharing the NWC of the George D. Lionberger 24.54-acre Tract III. The SWC of Lionberger shares the NWC of Holy Cow Performance Horses of Texas LLC 39.388-acre tract, Instr. 201302858, Parker County Deed Records, and is out by 1.85 feet. The SWC of Holy Cow Performance Horses shares the NWC of the Kenneth & Macia Hanson 40-acre tract and is out by 0.73 feet.

#### **FWTC BOUNDARY MAINTENANCE ISSUES**

On 26 July 2021, Point 46 was removed without permission by Texas Correctional Industries (TCI) seven months after we found the corner and marked it with an orange Carsonite witness post with the words DO NOT DISTURB—STATE LAW. The corner already had a T-post next to it for protection. Although I repeatedly advised the permanent FWTC staff not to remove, destroy, or alter any federal boundary corner or survey mark. they did not properly supervise TCI when they flagrantly bulldozed the corner and then placed the 2-inch pipe, Carsonite witness post and T-post in a pile at the base of the fence. TCI denied ever seeing the monument. Well then, which one of them gathered the corner and accessories and placed them next to the fence? The day after this incident, we reset Point 46 back to its original location. Some of the FWTC staff supervising TCI "didn't see the big deal" in removing a federal boundary corner. Before this incident, the FWTC staff were made aware of 18 U.S. Code § 1858 - Survey marks destroyed or removed: "Whoever willfully destroys, defaces, changes, or removes to another place any section corner, quarter-section corner, or meander post, on any Government line of survey, or willfully cuts down any witness tree or any tree blazed to mark the line of a Government survey, or willfully defaces, changes, or removes any monument or bench mark of any Government survey, shall be fined under this title or imprisoned not more than six months, or both." (June 25, 1948, ch. 645, 62 Stat. 789; Pub. L. 103–322, title XXXIII, § 330016(1)(E), Sept. 13, 1994, 108 Stat. 2146.)

The current laws in Texas dealing with willful destruction of survey marks is a little murky in that it falls under Section 28.03 of the Texas Penal Code (Arson, Criminal Mischief, and other Property Damage or Destruction), carrying penalties ranging from Class C, B, or A misdemeanors all the way up to state jail felony, from third-, second-, or first-degree felony, depending on the pecuniary cost. (Amended by Acts: 2007, 80th Leg. Ch. 690 (H.B. 1767), Sec. 1, eff. September 1, 2007).

During the Republic of Texas, criminal penalties were quite clear:<sup>2</sup>

- Theft Under \$20: A fine plus 39 lashes
- Horse Theft: A fine plus 39 lashes and the branding of a "T" on the hand
- Murder, Rape, Arson, Robbery, Burglary, Counterfeiting: Death

This incident and the removal of Point 3 is troubling for a staff whose job is to protect FWTC property. The problem evolves when the layperson does not understand that retracement surveys, engineering surveys and geodetic surveys are hard to do, and very time consuming. There was no good reason for destroying Point 46 when FWTC staff could have contacted me because I was surveying nearby that day.

#### CONCLUSION

This report is furnished with reference to a retracement survey of the indicated lands comprising the Fort Wolters Training Center made by me under my supervision from 7 November 2013 to 29 July 2021. A plat of this survey showing the construction of the captioned lands and field notes is furnished herewith. The above determination of the subject tract's location is based on a careful and diligent survey on the ground and research from multiple sources.
